



Redistricting Process

	Step	Action
	Census Data Release August 12	Census Bureau released Preliminary 2020 Census population data in legacy format.
	Community Redistricting Meetings September 2021	Seven (7) Community Redistricting Meetings to review the redistricting process, introduce the mapping tools and receive public input on neighborhoods/communities of interest.
	California Data Release Late September 2021	California Statewide Database releases California's official 'prisoner-adjusted' 2020 redistricting data, then a mandated three-week waiting period before maps are released.
	Draft Map Hearings Oct. 5, 2021 & Nov 2, 2021	Two Public Hearings to receive additional input and present initial draft maps.
	Community Redistricting Meetings November – December 2021	Seven (7) Community Redistricting Meetings to receive public input on neighborhoods/communities of interest and receive public input on draft maps.
,	Draft Map Hearings Jan. 2022 & Feb.2022	Two Public Hearings to discuss and revise the draft maps and to adopt the final map.
n H	Map Adoption By 4/17/2022	Final map must be posted at least 7 days prior to adoption. Map adopted via ordinance

Redistricting Rules and Goals

1. Federal Laws

- Equal population
- Federal Voting Rights Act
- No racial gerrymandering



2. California's Ranked Criteria

- 1. Geographic contiguity
- 2. Undivided neighborhoods and "communities of interest"
- 3. Easily identifiable boundaries
- 4. Compactness
 (Do not bypass one group of people to get to a more distant group of people)

Prohibited:

"Shall not favor or discriminate against a political party."

- 3. Other Goals & Traditional Principles
- Minimize voters shifted to different election years
- Respect voters' choices / continuity in office
- Future population growth
- Preserving the core of existing districts











Story Map

- □ Used to identify "communities of interest"








Simple Map Drawing Tool

- □ Total Population Counts only no demographic numbers








Simple Map Drawing Tool + Excel Supplement

The Redistricting Process

Every 10 years, local governments use new data from the Census to redraw their district lines to reflect how local populations have changed. Pursuant to Assembly Bill 849 (2019), cities and counties engage communities in the redistricting process by holding public hearings and workshops and doing public outreach, including to underrepresented and non-English-speaking communities.

Districts must be redrawn following each decennial federal census, so that each district is substantially equal in population. This process is important in ensuring that each City Councilmember and district represents about the same number of constituents. The City of Anaheim is asking for your help to plan, draw, and reshape new City districts.

The map of the City's current council districts was adopted by the City Council (Ordinance No. 6360) in February 2016, which served as the City's first boundary map [2016 Districting Process]. During the redistricting process, you will help us reshape the six Anaheim district boundaries, and these new districts will impact how you elect your Council Members for the next 10 years.

Our primary goal when developing election districts is to draw lines that respect neighborhoods, history and geographical elements. So we want to know: What do you consider the boundaries of your neighborhood?
